

ONLINE PRIVACY POLICY AGREEMENT

Effective Date: October 2, 2025

Wisteria Psychological Services, LLC (“Wisteria Psychological Services”) values your privacy. This Privacy Policy ("Policy") explains how we collect and use personal information from those who visit our website, make use of our online facilities and services, or consent to receive SMS/text communications from us. It also explains what we will and will not do with the information we collect.

Our Policy has been designed and created to ensure those affiliated with Wisteria Psychological Services of our commitment and realization of our obligation not only to meet, but to exceed, most existing privacy standards.

Information We Collect

The data we collect will be stored no longer than necessary. Retention will depend on:

- The relevance of the information.
 - Record-keeping obligations.
 - Legal or regulatory retention periods.
 - The type of contract we have with you.
 - The existence of your consent.
 - Our legitimate interest in keeping such information.

SMS/Text Messaging

- SMS communications are considered part of your service relationship with Wisteria Psychological Services and are used only for non-marketing purposes unless you explicitly consent otherwise.

Wisteria Psychological Services does not now, nor will it in the future, sell, rent, or lease any customer lists or names to third parties.

We may use personal information to:

- Assist in the operation of our website and services.
- Ensure delivery of the services you request.
- Inform you of products and services available from Wisteria Psychological Services.
- Conduct surveys and research regarding current or future services.

Wisteria Psychological Services uses various third-party social media features including, but not limited to, Facebook and Instagram. These may collect your IP address and require cookies to function properly. These services are governed by the privacy policies of the providers and are not within our control.

Disclosure of Information

Wisteria Psychological Services may not use or disclose your information except under the following circumstances:

- As necessary to provide services or products you have requested.
 - In ways described in this Policy or with your consent.
 - In aggregate form that cannot reasonably identify you.
 - As required by law, subpoena, or court order.
 - To outside auditors under confidentiality agreements.
 - As necessary to enforce our Terms of Service.
 - As necessary to protect the rights and property of Wisteria Psychological Services.
